KINDRED CITY COUNCIL MEETING MINUTES 7-5-2017

1. 7:00 MEETING CALLED TO ORDER

Mayor Wanner called the meeting to order at 7:00pm with council members Johnson, Amerman, and Spelhaug, present. Member Stoddard arrived at 8:05. Also present were City Engineer Brandon Oye, City Attorney Sarah Wear, Deputy Rufat Agayev, and City Auditor Kristi Olson. 2. APPROVE AGENDA

Discussion regarding keys for the memorial building and possibly rekeying all city buildings due to the change in staff. 2016-1 Water Tower – Project and funding update. Environmental review is completed and waiting for DWSRF funding to be approved. Discussion was had regarding whether to authorize auditor to

advertise and move forward with the project assuming the risk/responsibility of payment if funds are not approved in time or to wait for funding to be approved. The option to advertise contingent upon federal funding was also discussed.

Motion to authorize auditor to advertise for bids and begin construction prior to funding approval – Spelhaug, no second; motion failed.

Motion to authorize auditor to advertise for bids contingent on DWSRF funding approval – Johnson, second Amerman; RCV motion passed, Spelhaug-no, Amerman-yes, Johnson-yes, Stoddard-yes

2017-1 Newport Ridge-Phase 3 – Project update. Mr. Oye discussed the Engineering Agreement and billing schedule. Mr. Oye also sought approval for payment of Invoice 16030 to Moore Engineering for services rendered.

Motion to approve Engineering Agreement with MEI for 2017-1 Newport Ridge 6th Addition – Phase 3 – Stoddard, second Spelhaug; RCV motion passed.

Motion to approve payment of Invoice 16030 to MEI – Spelhaug, second Johnson; RCV motion passed.

Sanitary Sewer Improvements update. Still waiting for funding. Mr. Oye met with Fargo to discuss options to connect to Fargo's wastewater. He will provide preliminary options and costs at August meeting for consideration.

Amerman brought up concerns regarding insurance coverage for the shed that was just purchased and destroyed in the recent storm. Johnson discussed looking into the existing coverage to determine if the city has any options to recover those funds.
